# Special Conditions for Black Bass Tournaments without the Slot Limit Stipulation Tournament Participants are allowed to possess 5 fish with a minimum size of 12 inches. No Maximum size.

## For Tournament Director

All directors are responsible for advising their participants of all conditions and to monitor compliance.

A DNR-signed copy of these conditions must be displayed at the site of the tournament along with a copy of the permit.

The permittee or a tournament director must be present at the time of the weigh-in.

The participants of the tournament must possess a copy of a valid Participant Permit (see last page) signed by the Tournament Director.

The participants of the tournament must possess a valid fishing license to fish tidewater in the State of Maryland and personal identification.

Tournament organizers shall ensure that all fish are handled expeditiously in a manner that maximizes the survival of all fish.

### For Tournament Participants

Tournament participants may not possess or weigh-in more than the total daily bag limit for black bass (5), regardless of the number of weigh-ins.

Each boat will have one or more functioning aerated live well(s). Anglers not meeting this requirement may not participate in the tournament. A functioning live well is defined as one that has a working aeration or oxygenation system or a flow-through system to pump fresh water into the live well. Each live well shall be inspected by the permittee or a tournament official prior to the tournament's starting time to ensure they are operating properly.

Only artificial lures may be used.

A culling system must be utilized that reduces fish handling stress and injury (e.g., clips and color coding). Devices that require punching a hole in the fish's mouth are NOT permitted. Fish should not be lifted from a livewell by culling tubes, ropes, etc.

All dead fish are a part of a participants' bag and must be part of the weigh-in; no culling of dead fish.

A penalty of at least 0.25 pounds (four ounces) must be imposed on a participant for each dead fish.

Bass shall be transported to and from the vessel to the weigh-in site in water-filled containers with sufficient water to cover the fish, except during the actual measuring/weighing process.

Individual bass over approximately five (5) lbs shall be held in separate containers both before and after weighing.

Bass shall not be kept in water-filled containers longer than two (2) minutes prior to, during, and after weigh-in without supplemental aeration and/or water exchange.

#### After the Tournament

All tournament participants shall release fish to a holding tank and not release them directly to the water. To accommodate this, tournaments shall have mobile holding tank facilities for keeping bass alive and in good condition immediately following a tournament. Bass should be redistributed to an approved site following a tournament. Conditions for these holding tanks are:

- 1. Each tank shall hold a minimum of 100 gallons of water
- 2. Each tank shall be equipped with aeration, air injection, or oxygenation system

3. Holding tank water temperature shall be maintained at the river surface water temperature or no more than 5 - 7 degrees Fahrenheit below the surface water temperature

4. The number of bass confined shall not exceed one pound of bass per gallon of water.

When requested, the Maryland Department of Natural Resources' Fisheries Service may provide a holding tank and assist with the redistribution of fish, as long as the organization offsets Fisheries Service costs by providing volunteers and donations, with the latter exempted for organizations that serve individuals with physical or mental disabilities and veterans with service connected disabilities.

Insofar as possible, all fish shall be returned to the water alive and in good condition. All efforts should be made to release fish unharmed or in a manner that does not cause injury or death of the fish.

The permittee and tournament participants shall not keep or transport to an unapproved site any bass caught during the tournament.

<u>Other</u>

Additional Special Conditions may be added by Regional Fisheries staff as deemed necessary.

Failure to comply with the Special Conditions may result in the termination of the tournament and/or cancellation of remaining permits for that organization.

Department employees may terminate a contest if, in his/her opinion, any permit condition has been violated or a substantial impact to the resource by the contest is observed or expected.

Within 30 days following the tournament, the permittee shall submit a completed tournament activity report. Failure to submit the report will result in denial of future permits.

## **TOURNAMENT PARTICIPANT PERMIT**

This participant permit entitles an angler to possess 5 largemouth bass that have a minimum size of 12-inches.

The Participant is required to follow these conditions:

#### For Tournament Participants

Tournament participants may not possess or weigh-in more than the total daily bag limit for black bass (5), regardless of the number of weigh-ins.

Each boat will have one or more functioning aerated live well(s). A functioning live well is defined as one that has a working aeration or oxygenation system or a flow-through system to pump fresh water into the live well. Each live well shall be inspected by the permittee or a tournament official prior to the tournament's starting time to ensure they are operating properly. Anglers not meeting this requirement may not participate in the tournament.

Only artificial lures may be used.

A culling system must be utilized that reduces fish handling stress and injury (e.g., clips and color coding). Devices that require punching a hole in the fish's mouth are NOT permitted. Fish should not be lifted from a livewell by culling tubes, ropes, etc.

All dead fish are a part of a participants' bag and must be part of the weigh-in; no culling of dead fish.
